6. Legislative Update - information only
Staff reported on two CALAFCO bills: SB 1209, currently under Governor Newsom's review, and AB
3277 which was approved by Governor Newsom. The letter in support of SB 1209 submitted by CC
LAFCO was an attachment. Chair Lewis invited public and Commission comments; there were none.

- 7. Withdrawal of Dissolution of Alamo Lafayette Cemetery District information only Staff reported on the withdrawal of the application and a letter will be presented to the commission once acquired. Chair Lewis invited public and Commission comments; there were no public comments. Commissioner Perkins asked if this decision affects the study, and staff responded it does not. Chair Lewis discussed the cost of the study. Commissioner McGill noted the importance of the analysis.
- 8. Plan Bay Area 2050+ Draft Blueprint and Transit 2050+ Draft Network Plan information only Staff reported on the plans. Chair Lewis invited public and Commissioner comments. Commissioner McGill thanked staff and Chair Lewis commented on ABAG's predictive analysis.
- 9. Current and Potential Applications information only
 Staff commented on two new applications: one to expand Contra Costa County Fire Protection District's
 (CCFPD) sphere of influence to include the Rodeo-Hercules Fire Protection District (RHFPD), and the
 corresponding application to annex RHFPD to CCCFPD and dissolve RHFPD. Chair Lewis invited
 public and Commissioner comments; there were none.
- 10. Contra Costa County Employees' Retirement Association (CCCERA) correspondence information only
- 11. Commissioner Comments and Staff Announcements Staff provided information on the upcoming annual CALAFCO conference October 16-18, 2024, in Yosemite. CC LAFCO received the President's Special Acknowledgement Award for having zero paid claims for the years 2019 2024. Commissioner McGill noted his race for re-election and provided information on CALAFCO's consideration of possibly hiring a lobbyist. Commissioner Perkins asked why CALAFCO is considered a 501C3 and not a 501C4 entity and Chair Lewis stated the number of committee members. Commissioner Quinto noted the upcoming CAL Cities Conference in Long Beach. Commissioner Bristow asked why LAFCO does not recite the pledge of allegiance. Commissioner Andersen noted it was preferential and asked staff about opening with the pledge, Commissioner Bristow concurring. Chair Lewis cited background on the pledge and invited public comment. Public speaker Mariah Lauritzen noted the Preamble to the Constitution should be considered for recitation. Public comments were closed and the Commission agreed to discuss the pledge as an agenda item during the next LAFCO meeting.
