Results of Protest Hearing LAFCO 24-04 - Annexation of Rodeo Hercules Fire Protection District (RHFPD) to Contra Costa County Fire Protection District (CCCFPD) and Dissolution of RHFPD

Dear Commissioners:

The Rodeo Fire Protection District (RFD) was formed in 1937 (pre-LAFCO) as an independent fire district to serve the Rodeo community. In 1978, the City of Hercules was annexed to RFD, and the district became the Rodeo Hercules Fire Protection District (RHFPD). The RHFPD covers 32± square miles and includes the City of Hercules, the unincorporated Town of Rodeo community, and surrounding unincorporated areas. RHFPD is governed by a five-member elected board. The RHFPD serves a population of approximately 35,865 [Data Analysis: Contra Costa County Department of Conservation & Development].

RHFPD personnel includes 22 full-time and one part-time staff (presently unstaffed). RHFPD deploys its apparatus and personnel from two fire stations. RHFPD also provides code enforcement, fire inspections, plan reviews, fire cause investigations, and public education and prevention programs.

Regarding funding, RHFPD is a smaller district that has seen growth in property value with moderate increases in property tax revenue which are being outpaced by expenses, leaving a forecasted ongoing structural deficit in the near future. Property tax revenues are negatively impacted by the dissolution of redevelopment agencies and the continued property development within the City of Hercules Redevelopment Area. Measure O and the 1998 Benefit Assessment District funds will continue to be committed to funding services within the RHFPD service area following the recent annexation and dissolution.

Over the years, there were several studies and LAFCO Municipal Service Reviews (MSRs) covering fire services. These studies concluded that RHFPD is not sustainable in the long term, and that annexation to CCCFPD is the preferred governance option as approved by the LAFCO Commissioners on December 11, 2024.

Following two LAFCO public hearings in November 2024 and December 2024, the LAFCO Commissioners unanimously approved the sphere of influence amendment and boundary reorganization, respectively. Subsequently, pursuant to the *Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000*, the LAFCO Executive Officer conducted a protest hearing, the purpose of which was to receive written protests from affected landowners/registered voters regarding the proposal and determine whether a majority protest exists. Following the protest hearing, written protests were to be counted.

The LAFCO Executive Officer reports that there were no verbal or written protests at the January 22, 2025 LAFCO protest hearing.

RECOMMENDATION

It is recommended that the Commission receive the results of the protest hearing, find that there are insufficient protests to order an election or terminate the LAFCO proceedings, and order the annexation of RHFPD to CCCFPD and dissolution of RHFPD per the Executive Officer's Determination (attached).

DETERMINATION OF THE EXECUTIVE OFFICER OF CONTRA COSTA LOCAL AGENCY FORMATION COMMISSION FINDING THERE ARE INSUFFICIENT WRITTEN PROTESTS TO ORDER AN ELECTION OR TERMINATE THE PROCEEDINGS RELATING TO ANNEXATION OF RODEO HERCULES FIRE PROTECTION DISTIRCT (RHFPD) TO CONTRA COSTA COUNTY FIRE PROTECTION DISTRICT (CCCFPD) AND DISSOLUTION OF RHFPD (LAFCO 24-04)

1. This action is taken pursuant to the Cortese Knox Hertzberg Local Government Reorganization Act (Government Code §56000 et seq.) and policies of the Contra Costa Local Agency Formation Commission (hereafter Commission).

Proceedings for *annexation of RHFPD to CCCFPD and dissolution of RHFPD* were initiated by the *CCCFPD* and *RHFPD* Boards of Directors and filed with the Executive Officer of Contra Costa LAFCO on August 8, 2024. The reasons for the boundary reorganization and dissolution of RHFPD include the following:

- a) Enhance and expand fire and emergency medical services to the Rodeo Hercules area;
- b) Improve efficiency, effectiveness, and economy of fire protection services within the subject area; and
- c) Better meet the fire, rescue, and emergency medical service needs of the residents.
 - 2. On December 11, 2024, the Commission adopted Resolution No. 24-04, making determinations and approving the annexation and dissolution subject to certain conditions.
 - 3. Acting on delegated authority from State law and the Commission, the Executive Officer, on January 22, 2025, conducted a properly noticed public hearing to receive protests filed against the dissolution. Following the conclusion of the hearing, the Executive Officer found that no written protests were filed.
 - 4. Finding there are insufficient protests to order an election or terminate the LAFCO proceedings, Contra Costa LAFCO hereby orders *annexation of RHFPD to CCCFPD and dissolution of RHFPD* subject to the terms and conditions contained in the Commission's resolution of approval, Resolution No. 24-04.

Fiscal Year 2024-25 Mid-Year Budget Report

Dear Members of the Commission:

This is the second quarter (mid-year) budget report for FY 2024-25, which compares adopted and actual expenses and revenue for the period July 1, 2024 through December 31, 2024.

The LAFCO operating budget includes several components: salaries/benefits, services/supplies, a contingency/reserve fund, Other Post-Employment Benefits (OPEB) and retirement pre-funding accounts. The budget is based on the "bottom line," which allows for variation within line-item accounts if the overall balance remains positive. Funds may not be drawn from the contingency/reserve without Commission approval.

The LAFCO budget is funded primarily by the County, cities, and independent special districts, with each group paying one-third of the LAFCO expenses. The County pays one-third, and the city and district shares are prorated based on general revenue reported to the State Controller's Office. LAFCO also receives revenue through application fees and interest earnings.

DISCUSSION

On June 12, 2024, the Commission adopted the final FY 2024-25 LAFCO budget with total appropriations of \$1,034,702, which includes an \$87,000 contingency/reserve fund. The FY 2024-25 budget includes \$30,000 prefunding of the Other Post-Employment Benefits (OPEB) and \$25,000 prefunding of the Contra Costa County Employees' Retirement Association (CCCERA).

With 50% of the fiscal year elapsed, the LAFCO's total expenditures are \$400,812 or 42% of total appropriations (including contingency). The Commission budgeted \$480,492 in *salaries/benefits* for FY 2024-25; at the end of the second quarter, actual expenses total \$221,272 or 46% of the budgeted amount. The Commission budgeted \$412,210 in *services/supplies*; and at the end of the second quarter, actual expenses total \$179,540 or 44% of the budgeted amount.

The primary sources of revenue are local agency contributions, application fees, and available fund balance. Total revenue received during the first half of FY 2024-25 is \$1,009,845 (including

appropriated fund balance) or approximately 97.6% of estimated revenues. As of this writing, all local agencies have remitted their annual apportionments to LAFCO.

As for application activity, FY 2024-25 mid-year application activity is comparable to FY 2023-24. During the first half of FY 2023-24 LAFCO received two new applications, and during the first half of FY 2024-25 LAFCO received two new applications.

Other revenues include investment earnings through the OPEB trust account, which remains in that account, and fund balance. LAFCO budgets fund balance to offset agency contributions. The FY 2024-25 budget includes \$250,000 in budgeted fund balance. See table below for a summary of mid-year expenditures and revenues.

Fiscal Year 2025-26 Proposed Budget Schedule and Work Plan Preview

Dear Members of the Commission:

The Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH Act) establishes a specific process for preparing and adopting LAFCO's budget. Government Code §56381 provides that the Commission shall annually adopt a proposed budget by May 1 and final budget by June 15, following noticed public hearings.

LAFCO staff anticipates bringing a proposed budget to the Commission in April 2025 and a final budget to the Commission in June 2025. In conjunction with the proposed budget, the Commission receives an annual work plan which includes a summary of recent activities and accomplishments along with upcoming projects and activities as summarized below.

ACCOMPLISHMENTS AND ACTIVITIES

MSRs/SOI Updates - LAFCO law provides that LAFCO review and update each SOI [Gov. Code §56425(g)]. The statute also provides that in order to prepare and update a SOI, the Commission shall conduct an MSR.

To date, LAFCO has completed its inaugural round and most 2nd round MSRs/SOI updates. The most recent MSRs, including completed, underway, and next in the queue, are noted below:

- Work with Policies & Procedures Committee on updating policies and procedures as determined by the Commission

Staffing - LAFCO is currently staffed with two full-time employees. LAFCO supplements its staff with contract consultants and County services including environmental planning, GIS/mapping, legal, finances (Auditor and Assessor), information technology, and other services.

LAFCO Activities – To date, FY 2024-25 LAFCO activities and accomplishments include the following:

Update to LAFCO Employee Salary Ranges

Dear Members of the Commission:

As an independent entity created by the State Legislature, LAFCO hires its own staff and provides employee benefits, including health, dental, retirement, and other employee benefits. Contra Costa LAFCO purchases most of its employee benefits from Contra Costa County, and its retirement benefits from Contra Costa County Employees' Retirement Association (CCCERA).

In 2007, LAFCO adopted its own personnel system, including an Employee Benefit Plan (last updated December 2023), job descriptions, and an employee Salary Plan. The Employee Benefit Plan is updated with changes to the County management employee benefit plan, and the Salary Plan is updated annually.

Contra Costa LAFCO currently employs two full time employees – an Executive Officer ("EO") and a Clerk Analyst ("CA"). To keep Contra Costa LAFCO salaries current and competitive, LAFCO staff conducts an annual salary survey of the Bay Area and Urban LAFCOs for the following LAFCO positions: LAFCO EO, Executive Assistant/Clerk, Analyst I/II, and CA.

Based on the recent LAFCO salary survey, the Bay Area Consumer Price Index (CPI), cost of living factors, and Contra Costa County's salary increases, it is recommended that the Commission update the LAFCO Salary Plan by increasing the salary ranges by 4% for the Executive Officer, Executive Assistant/Clerk, Analyst I/II positions, and Clerk/Analyst positions. The proposed adjustments to the salary ranges do not automatically result in adjustments to employee salaries. LAFCO employee salary adjustments are based solely on performance. LAFCO employees do not receive annual cost-of-living adjustments. The Commission typically conducts an annual performance review for the EO and approves salary adjustments based on performance. The EO conducts annual performance reviews for the other LAFCO employees and provides salary adjustments based on performance. Salary increases for these positions occur in conjunction with annual performance reviews.

LAFCO employee benefits and salary ranges are provided at the discretion of the Commission and can be modified as deemed appropriate. The benefit plan and salary ranges are reviewed periodically to keep pace with market conditions.

RECOMMENDATIONS

It is recommended that the Commission approve LAFCO Resolution 2025-01 increasing the salary ranges by 4% for the Executive Officer, Clerk Analyst, Analyst I/II, and Executive Assistant/ Clerk positions.

WHEREAS, the salary ranges for the other LAFCO positions were last reviewed in February 2024 and should be reviewed annually and adjusted to keep pace with market conditions.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED that:

- 1. Contra Costa LAFCO hereby increases the LAFCO salary ranges for the Executive Officer, Analyst I/II, Clerk Analyst, and Executive Assistant/LAFCO Clerk positions by 4% as shown in Exhibit A. These salary ranges reflect a recent survey of comparable Bay Area and Urban LAFCOs, Bay Area Consumer Price Index, and current market conditions.
- 2. Contra Costa LAFCO employees receive no Cost-of-Living Adjustments (COLAs) and may receive an annual salary increase based solely on performance.

CALAFCO Update

Dear Commissioners:

The California Association of Local Agency Formation Commissions (CALAFCO) continues to have challenges. As previously reported, there was an effort by CALFCO to dissolve the CALAFCO Legislative Committee. 34 LAFCOs, including Contra Costa, sent letters expressing concern with dissolution of the Legislative Committee. Ultimately, the CALAFCO Board voted to retain the CALAFCO Legislative Committee.

In October and November 2024, several LAFCOs sent letters expressing concerns with CALAFCO dues and prioritization of CALAFCO's mission. One LAFCO gave notice to CALACO that they will not renew their membership as of July 1, 2025.

On December 23, 2024, a letter was sent to the CALAFCO Board of Directors noting concerns with the CALAFCO Board and leadership. There are 58 LAFCOs in California. The letter was signed by 17 LAFCO Executive Officers who serve 21 LAFCOs throughout the State. The letter includes a number of concerns, noting that "CALAFCO leadership has lost focus on its core mission" and that "CALAFCO's focus on the interests of the membership must be restored in order to build lost trust and to ensure the Association's survival." The letter also expressed concerns regarding lack of outreach and transparency, appointment of the CALAFCO regional executive officers by the CALAFCO Executive Director, and communication and building relationships with the membership. Subsequently, the CALAFCO Executive Director vacated her position. In the interim, José Henriquez, Executive Officer, Sacramento LAFCO is temporarily serving as the CALAFCO Executive Director.

On January 10, 2025, the CALAFCO Board of Directors met to discuss the future of CALAFCO. Another CALAFCO Board meeting is scheduled for Friday, February 7, 2025. The tentative agenda includes a Closed Session and a Regular meeting. The designated time of these meetings is not yet confirmed. Once LAFCO staff has confirmed meeting dates, we will share this information with Commissioners.

RECOMMENDATION: Discuss and provide comments regarding the future of CALAFCO.
